## 6. Contract description and Objective of the service

Service Contract for the provision of a study and related instruments to assess the level of legal awareness of people, particularly women and children victims of violence, of marginalized areas of the governorates of Palestine. Their knowledge about their rights and how to access justice should be evaluated and specifically their knowledge about the existing legal tools to protect survivors, to promote a safe environment to prevent violence and the existing legal counselling services to GBV survivors.

The objective of the study is to identify the most vulnerable areas where legal raising awareness and legal counselling activities for vulnerable groups, particularly women and children victims of violence will be implemented by AICS Jerusalem in the aforementioned programme3.







The identification of the areas must be based on verifiable indicators about the legal awareness of the community members, particularly GBV Survivors Women and Children, the existing services in favor of GBV Survivors and the access to legal counselling.

The final findings of the study will be used as a baseline of the future implementation of activities of raising awareness and legal counselling.

The tenderer will:


- Be an official Palestinian non-profit organization

- Have at least 3 years of experience in providing legal counselling and raising awareness activities in relevant issues in vulnerable areas of West Bank
- Gave at least 3 years of experience in implementing activities and/or project related to the GBV issues
- Have published reports and/or studies related to the situation of human rights in Palestine
