Service Contract for the provision of monitoring and evaluation services to cover the three-year programme AMAL — Human Rights and Gender Equality in Palestine. It will include the establishment of the process to develop an initial, mid-term and final evaluation. The use of tools and approaches that are internationally recognized within innovation, co-creation, real-time evaluation, developmental evaluation and formative evaluation is required, including the facilitation of community-based participatory monitoring processes which will assure an ongoing assessment of the changes promoted by the action and the identification of evaluation tools related to process-oriented metrics and to sense-making.
