Service contract for the provision of consultancy activities related to the issue of disability on Palestinian legislation.

The offer of technical consultancy aims to consolidate the competences of the officials of the Ministry of Social Developments and other Ministries as well as the Civil Society Organizations staff on the rights of people with disabilities and the related legislation, including the main legal aspects and procedures. Special emphasis must be placed on the role and responsibility of every Ministry and other stakeholders involved such as CSOs.

The consultancy services must be provided through two trainings to be held approximately on the following dates: 4th-5th December 2019 and on 18th-19th December 2019 in Palestine.

Once that one or more applicants will be selected, AICS will determine the specific focus of the activities.

Tender criteria

The tenderer will:

- Have at least 3 years of experience in providing consultancy services on the rights of people with disabilities
- Have at least 3 years of experience in providing training activities to ministerial officers.
