## 6. Contract description and objective of the service

Service contract for the provision of Legal Clinics to GBV survivors and legal awareness workshops to communities and families in the surrounding area of Salfit, including coordination and supervision activities of similar initiatives financed by the Italian Agency for Development Cooperation – Jerusalem Office in the surrounding areas of Tulkarem and Nablus.

The activity aims to raise communities and families' awareness about existing legal tools to protect survivors, to promote a safe environment to prevent violence and give legal counselling to GBV survivors. Legal advice can be provided on the spot or, if the case require further consultation, the matter will be researched on and communicated later to the beneficiary. The activity includes the elaboration and printing of hand-manuals, brochures and stickers to be distributed during field visits and to the Tawasol centres, including key information and messages to prevent and combat GBV. Furthermore, the activity shall coordinate and supervise the implementation of similar initiatives
