6. Contract description and objective of the service

Service contract for the provision of support and technical advisory services to Palestinians living in East Jerusalem for the contribution to a process of planning and development for housing purposes in a legal setting and raising awareness in the local community.

The activity aims at providing legal and technical services to assist Palestinians facing displacement and demolition orders in East Jerusalem. This activity will be carried out through a social entity that will be established to provide legal and technical services for Palestinians in East Jerusalem to assist in land disputes to prevent displacement and design urban planning alternatives, through a cooperative approach. In addition, the activity will comprise a raising awareness component that must target the local Palestinian community and stakeholders to promote knowledge on the services that the housing cooperatives can provide to strengthen their role in the community and gather them under common social goal.

7. Indicative budget

Up to 270.290 euros.

Participation in tendering is open on equal terms to International Organizations and Civil Society Organizations registered in Palestine that have worked on a domain related to the scope of contract in Palestine in the last two years.
